**PLEASE READ THIS LICENSE BEFORE INSTALLING OR USING THIS SOFTWARE. OPENING OR INSTALLING THIS SOFTWARE PACKAGE INDICATES YOUR ACCEPTANCE OF THE TERMS AND CONDITIONS OF THIS LICENSE.**

### TERMS AND CONDITIONS

#### 1. Definitions

1.1 Definitions. The following terms shall have the meaning ascribed below:

(a) **"Documentation"** means all manuals that relate to the Software or Third Party Software including, without limitation, all operations, design, user (operational, educational or otherwise) and support and maintenance manuals and all other print or electronic materials relating to the Software or Third Party Software.

(b) **"Licensee"** means the legal entity that opens, installs or uses the Software.

(c) **"Third Party Software"** means third party software components that are included free of charge with the Software and that were created by various individuals and entities other than Company.

(d) **"Software"** means all versions of the ListEdit framework software products or any portion thereof including all Documentation and Upgrades and any modifications or additions thereof, but excludes the Third Party Software.

(e) **"Company"** means WEBAPPZ Systems, Inc. and any related entities.

(f) **"Authorized Development System"** means any computer on which you are licensed to install the Software for development purposes, and that runs any version of the following operating systems: (i) Apple's Mac OS, (ii) Microsoft's Windows

(g) **"Authorized Deployment System"** means a computer that runs an operating system that supports Java 2 technology and which is either owned and/or operated (i) by you for your internal use, or (ii) by a third party as a web application server, provided that you have a written agreement with such third party that protects Company's interest in the Software at least to the same extent as this license.

(h) **"Number of CPU's"** means the number of processors where the Software is installed and/or running. For the purposes of counting the number of processors which require licensing, a multicore chip with "n" processor cores shall be counted as "n" processors.

#### 2. License

2.1 License. Company hereby grants to the Licensee a perpetual (unless terminated as set forth herein) and nonexclusive license to use the object code for the Software subject to the terms and conditions of this License.

#### 2.2 Permitted Uses.

(a) **License to Develop Software Application Programs**. If Licensee has been provided with a developer license key, enabling Licensee to install the Software for development purposes, then subject to the terms and conditions of this License, Company grants to Licensee a personal, non-exclusive license to:

(i) install and use a single copy of the Software on one (1) Authorized Development System, solely for the purpose of developing application programs.

(ii) make one copy of the Software for backup and archival purposes only, provided that: (a) the original and the copy are kept in the Licensee's possession; and (b) the Licensee reproduces the Company copyright notice on such a copy.

(iii) make a one-time permanent transfer of the Software and all of Licensee's license rights to the Software, to a third party provided that:

(a) the transfer must include all of the Software (in its original form as provided by Company), including all its component parts, original media, printed materials and this License; (b) Licensee does not retain any copies of the Software, full or partial, including copies stored on a computer or other storage device; and (c) the receiving party reads and agrees to accept the terms and conditions of this License.

(b) **License to Deploy Server-Based Application Programs**. If Licensee has been provided with a deployment license key enabling Licensee to install the Software to deploy application programs developed using the Software, then subject to the terms and conditions of this License, Company grants to Licensee a personal, non-exclusive license to:

(i) install a single copy of the Software on one Authorized Deployment System, where the number of CPUs in the system may not exceed the number of CPUs specified in the license key. Licensee may add additional CPUs to the existing License by purchasing additional CPU licenses.

(ii) access and use the Software and any related application installed on the Authorized Deployment System and permit others to access and use the same in connection with Licensee's use from any remote computer.

(iii) make a one-time permanent transfer of the Software and all of Licensee's license rights to the Software, to a third party provided that:

(a) the transfer must include all of the Software (in its original form as provided by Company), including all its component parts, original media, printed materials and this License; (b) Licensee does not retain any copies of the Software, full or partial, including copies stored on a computer or other storage device; and (c) the receiving party reads and agrees to accept the terms and conditions of this License.

#### 2.3 Prohibited Uses.

**General:** The Licensee may not:

(a) Reverse engineer, decompile, or disassemble the Software;

(b) Copy, transfer or resell the Software or any copies thereof except as expressly provided in this License;

(c) Use run-time versions of third-party products embedded in the Software for any use other than the intended use of the Software;

(d) Use any backup or archival copies of the Software for any purpose other than for test purposes or to replace the original copy in the event it is destroyed or becomes defective;

(e) Sublicense, lease, loan or rent the Software or any modifications thereto; or

(f) Use or modify the Software in any way not expressly provided in this License.

**Developer License:** The Licensee may not:

(a) use the Software for your own internal data processing or for any commercial or production purposes, or use the Software for any purpose except the development of a single prototype of your application;

(b) use the application you develop with the Software for any internal data processing or commercial or production purposes without securing an appropriate license from Company;

(c) continue to develop your application after you have used it for any internal data processing, commercial or production purpose without securing an appropriate license from Company.

#### 3. Support and Maintenance

3.1 Support Services. This Agreement entitles Licensee to support services under the following provisions:

(a) Licensee has purchased a deployment license key to the Software;

(b) Company has received a completed registration form along with a copy of the receipt evidencing payment for the Software.

(c) Support services will commence on the date of initial receipt of the Software by the Licensee and for a period of 90 days thereafter and to a maximum of fifteen (15) hours for the single CPU deployment license and (30) hours for the double CPU deployment license (the "Support Period"). Company shall provide support services (the "Basic Services") to the Licensee by telephone and email as reasonably required to assist the Licensee in the installation and maintenance of the Software in accordance with the Documentation.

3.2 Additional Services. Any services in addition to the Basic Services (such as installation or maintenance of the Third Party Software, customization or on-site installation services) shall be provided to the Licensee on a time and materials basis in accordance with the then-current fees and availability of Company.

3.3 Updates/Upgrades. Company shall provide to the Licensee having purchased a deployment license, any updates and upgrades (the "Upgrades") to the Software that are released within one year from purchase date. Upgrades shall not include new functional releases of the Software. The distinction between functional releases and Updates shall be made by Company in its sole discretion.

#### 4. Intellectual Property

4.1 Copyright and Trade Secrets. The Software is licensed, not sold. Title and copyright in and to the Software including accompanying printed, embedded, or on-line materials or Documentation, and any copies made as permitted herein, are owned by Company. The Licensee acknowledges that the Software constitutes valuable trade secrets and proprietary information of Company and that no term of this License shall be construed to convey title in any part of the Software to the Licensee. The Licensee further agrees to keep the Software confidential and not to disclose the contents of the same (or any portion thereof) to any person or entity without the prior written consent of Company.

4.2 Modifications. Any modifications or additions to the Software shall be owned by Company and all copyright or other intellectual property rights therein shall accrue solely to Company.

#### 5. Limitations and Express Disclaimers

5.1 NO WARRANTIES. THE SOFTWARE AND THIRD PARTY SOFTWARE ARE PROVIDED ON AN "AS IS" BASIS. TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, COMPANY AND ITS LICENSORS DISCLAIM ALL REPRESENTATIONS, WARRANTIES AND CONDITIONS, EITHER EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO IMPLIED REPRESENTATIONS, NON-INFRINGEMENT WARRANTIES OR CONDITIONS OF DURABILITY, MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.

5.2 LIMITATION ON DAMAGES. IF FOR ANY REASON COMPANY BECOMES LIABLE TO THE LICENSEE OR ANY OTHER PARTY FOR DIRECT OR ANY OTHER DAMAGES FOR ANY CAUSE WHATSOEVER, IN CONTRACT OR TORT OR FOR STATUTORY FORMS OF ACTION, IN CONNECTION WITH THIS LICENSE OR COMPANY PRODUCTS OR SERVICES, THE AGGREGATE LIABILITY OF COMPANY FOR ALL DAMAGES, INJURIES AND LIABILITY INCURRED BY THE LICENSEE AND ALL OTHER PARTIES IN CONNECTION WITH THIS LICENSE AND COMPANY PRODUCTS AND SERVICES SHALL BE LIMITED TO THE TOTAL AMOUNT ACTUALLY PAID BY THE LICENSEE FOR THE LICENSES OR SERVICES THAT GAVE RISE TO THE CLAIM FOR DAMAGES.

5.3 NO LIABILITY FOR CONSEQUENTIAL DAMAGES. 6.2 Termination. Company may terminate this License upon any material breach of this License by the Licensee that is not cured within 10 days following written notice thereof. Upon termination of this License for any reason, all licenses granted hereunder will terminate and the Licensee shall immediately return to Company the Software and all copies thereof in any form.

#### 7. U.S. Export Restrictions

Licensee acknowledges that the Software is subject to U.S. and Canada export controls. Licensee will comply with all such laws and regulations and agrees not to re-export, divert, or otherwise transfer the Software to any destination, company, or person restricted or prohibited by such export controls and Licensee acknowledges that it is not such a company, or person. The Software provided hereunder might also contain encryption, which will be subject to particularly strict U.S. and Canadian export restrictions that limit Licensee's rights of use specifically set forth in this Agreement. In the event Licensee obtains the Company's prior written consent to relocate the Software to a location outside the U.S. and Canada, Licensee will be solely responsible for complying with the applicable export controls and will indemnify and hold the Company harmless from any liability or expense that may result as a failure of Licensee to comply with such export controls.

#### 8. General

8.1 Severability/Waiver. If any provision of this License shall be determined by a court of competent jurisdiction to be illegal, invalid or unenforceable, the remaining provisions shall remain in full force and effect.

8.2 Injunctive Relief. The Software is a strategic and valuable asset of Company that includes trade secrets. Any breach of the terms under this License or of confidentiality by the Licensee hereunder may result in harm and economic loss not compensable by monetary damages. Company shall be entitled to an injunction against such breach or threatened breach, in addition to other legal or equitable remedies.

8.3 Governing Law and Dispute Management. This License will be governed by and construed, interpreted and enforced in accordance with the laws of the Province of British Columbia and the federal laws of Canada applicable therein. The Licensee irrevocably submits to the non-exclusive jurisdiction of the courts of the Province of British Columbia.

8.4 Entire Agreement. This License constitutes the entire agreement between Company and the Licensee. The terms of this License shall prevail notwithstanding any different, conflicting, or additional terms that may appear in any other document. All products and services delivered by Company to the Licensee are subject to the terms of this License unless specifically addressed in a separate written agreement.

8.5 Binding on Successors. This License shall ensure to the benefit of and be binding upon each of the parties and their respective successors and permitted assigns.

8.6 Survival. Sections 1.1, 2.3, 4.1, 4.2, 5.1, 5.2, 5.3, 7, 8.1, 8.2, 8.3, 8.4, 8.5 and 8.6 shall survive termination of this License.
